Each proposal submitted must be accompanied by a certified check or bid bond, made payable to the **EAST ISLIP UNION FREE SCHOOL DISTRICT**, in an amount equal to ten percent (10%) of the total amount of the bid, as a commitment by the bidder that, if its bid is accepted, it will enter into a contract to perform the work and will execute such further security as may be required for the faithful performance of the contract. **Certification of bonding company is required for this bid: See Instructions for Bidders section.** Each bidder shall agree to hold his/her bid price for forty-five (45) days after the formal bid opening.

A pre-bid meeting and walk thru is scheduled for **Tuesday, 01/23/2024, starting at 3:30PM at East Islip High School.** Potential bidders are asked to gather at the **High School Main Lobby**, at which time they will be escorted throughout all areas of the work. Although **not** mandatory, it is highly recommended that all potential bidders review existing project site conditions prior to submitting their bid.

It is the Board's intention to award the contracts to the lowest qualified bidder providing the required security who can meet the experience, technical and budget requirements. The Board reserves the right to reject any or all bids, waive any informality and to accept such bid which, in the opinion of the Board, is in the best interests of the School District.
